HIGHER CERTIFICATE IN MINISTRY (NQF 5) | SAQA CODE 36202

The Higher Certificate in Ministry has a strong emphasis on preparing students to be involved in lay ministry within a local church. A basic foundation of core biblical and doctrinal knowledge is also established.

Entrance Qualification:

Matriculation or equivalent.

Graduation Requirements:

In order to graduate with the Higher Certificate in Ministry, the student needs to successfully complete a minimum of 120 credits and all compulsory courses.

BACHELOR OF BIBLICAL STUDIES (NQF 7) | SAQA CODE 50350

The Bachelor of Biblical Studies is a three-year programme to equip students for ministry. This qualification offers a complete biblical and theological foundation, covering all books of the Bible and all key doctrines. Biblical languages are also taught at either an elementary or advanced level, depending on the student's ability and interests. Students also have a broad exposure to different ministry areas. Core courses also include church history and practical ministry exposures.

Entrance Qualification:

Matriculation or equivalent.

Graduation Requirements:

In order to graduate with the Bachelor of Biblical Studies, the student needs to successfully complete a minimum of 360 credits, all compulsory courses and at least one major of the practical theology ministry tracks (pastoral studies, youth studies, or missiology).

BACHELOR OF THEOLOGY (NQF 8) | SAQA CODE 50354

The Bachelor of Theology is a four-year training programme to equip students for ministry. This qualification offers a complete biblical and theological foundation, covering all books of the Bible and all key doctrines. Biblical languages are also taught at either an elementary or advanced level, depending on the student's ability and interests. Students also have a broad exposure to different ministry areas. Core courses also include church history and practical ministry exposures. The fourth-year of this qualification allows students to intentionally specialize in a focused ministry area and has a strong research emphasis.

Entrance Qualification:

Matriculation or equivalent.

Graduation Requirements:

In order to graduate with the Bachelor of Theology, the student needs to successfully complete a minimum of 480 credits, all compulsory courses and at least one major of the practical theology ministry tracks (pastoral studies, youth studies, or missiology).

FINANCE

By submitting your application, you agree to the following:

1. You are required to regularly consult the statement of account that is sent to the email address of the person responsible for the account. Should the person responsible for the account not be yourself, you acknowledge that you, the student, are ultimately responsible for the payment of the amounts owed to the College, should that person fail to fulfil their commitment.
2. That to the best of your knowledge, the financial information that has been provided to the College is true and that no information has been withheld with regards to the National Credit Act.
3. You acknowledge that you are fully aware of the terms and conditions of payment which are that:
 - a. The registration fee, technology fee, and cost of one course are payable upon registration;
 - b. A further 50% of the remaining amount owing for the semester is payable by 31 March (1st Semester) and 31 August (2nd Semester) respectively;
 - c. The remaining 50% of the amount owing for the semester is payable by 31 May (1st Semester) and 31 October (2nd Semester).
4. Failure to adhere to the above terms of payment may result in the termination of the student's studies, possibly even within the semester where a payment milestone has not been met.
5. You acknowledge that you are liable to settle all charges incurred while you are studying at BTC.
6. You understand that you will not be able to register for the next semester until your account from the preceding semester has been settled in full.
7. You grant BTC permission to disclose your academic results to the person responsible for the payment of the account as well as other sponsors who have supported you financially (if applicable).
8. Should you stop your studies due to an outstanding amount owing on your account, you agree to settle the outstanding amount as soon as possible, even if you do not intend on undertaking further studies. Should this debt become bad, you acknowledge that the College reserves the right to hand your account over to the Trans Union ITC Credit Bureau after which you may be blacklisted.
9. You acknowledge that you are aware of the cancellation terms which are as follows:
 - a. The registration, technology, and RPL fees are non-refundable;
 - b. Written cancellation before the starting date of the semester: 100% refund of course fees paid;
 - c. Written cancellation in the first two weeks of the semester: 90% refund of course fees paid;
 - d. Written cancellation in weeks 3-4 of the semester: 70% refund of course fees paid;
 - e. Written cancellation in week 5 of the semester onward: 0% refund of course fees paid.
10. Students renting student accommodation acknowledge that rent is payable according to the terms of the lease agreement. The deposit and first month's rent is payable before occupancy.
